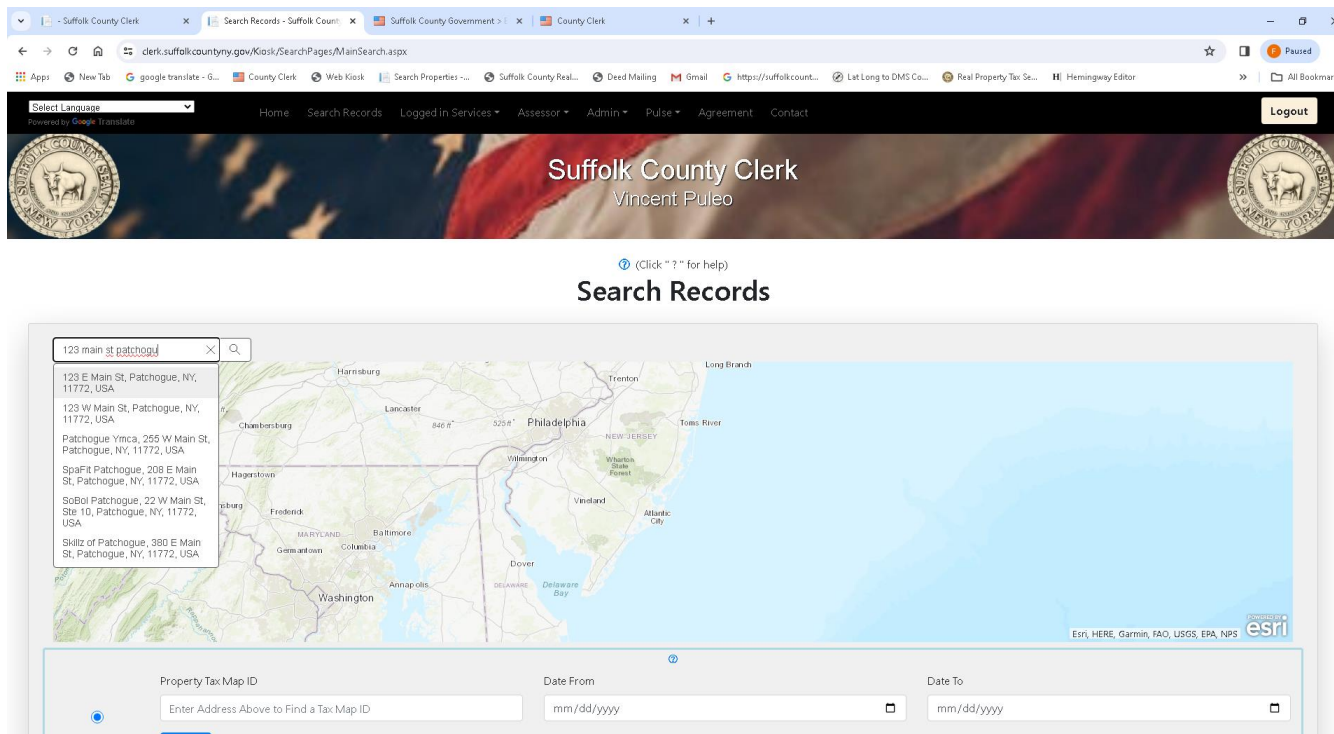


# Homeowner Watch List (HOWL)

## Registration Instructions

On the **Search Records** page on the Clerk's Kiosk website, enter the property address and select from the dropdown menu. **NOTE:** If you are searching a condominium you cannot use the property address to search. You must enter the exact **Tax Map Number** for the property. If you do not have the Tax Map Number you may contact the Town Assessor's office in which the property is located. (The **Search Records** page can be accessed by the link at the bottom of this page. Please read the instructions fully before accessing the webpage.)



**Click** on the house where it is located on the map. (The **HOWL** link will take a few seconds to become available.)
